The Indianapolis School of Ballet's scholarship policy is designed to promote students' disciplined study of high-quality dance instruction. Scholarships are awarded to students based on financial need, attendance record, artistic ability and promise, effort demonstrated in class, involvement in ISB performances and availability of funds.

- Scholarships are awarded for students in the pre-professional and summer intensive programs and are targeted towards female dancers in levels 4 through the Professional Level Program and male dancers in levels 1 through the Professional Level Program.
- Students who have been enrolled full-time and who have completed at least two semesters of study in ISB's Pre-Professional Program and demonstrate financial need receive priority in scholarship decisions.
- Scholarship awards are not final until both the student (or parent if the student is younger than 18 years old) and ISB complete and sign the Scholarship Award Agreement. Students who fail to adhere to the conditions of the agreement risk losing their scholarship.
- Students with an outstanding balance may not be eligible for scholarships.
- Scholarships will range from 5% to 50% of the tuition cost. Only severe hardship cases will be reviewed and/or awarded scholarships above 50%.

All students who wish to receive a financial aid scholarship award must do the following:

1. Complete **Registration Form** and **Scholarship Application**.
2. Gather supporting documentation for Scholarship Application form.
  - a. Most recent school report card
  - b. Proof of Household Income for the parent(s) and/or legal guardian in which the student resides. (Must be submitted to be considered for need based scholarship.)
    - i. Signed copy of most recent Federal Income Tax Form and 2023 W2s or
    - ii. Most recent TANF Form, or
    - iii. Most recent SSI Notification.
    - iv. If unemployed – most recent unemployment verification
3. Deliver complete forms and supporting documentation to ISB offices on or before **July 22, 2023**.
4. Sign and adhere to the conditions of their **Tuition Payment Form** and/or **Scholarship Agreement**.  
**(Will be provided when scholarship is awarded.)**
